All those pieces parcels or lots of land in Gantt Township, Greenville County, State of South Carolina being known and designated as Lots Nos. 37 and 38 of Donaldson Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "KK", Page 17 and being described together according to said plat as follows:

BEGINNING at an iron pin on the western side of Charles Drive at the joint front corner of Lots Nos. 36 and 37 and running thence along the joint line of said lots, S.80-04 W. 175 feet to an iron pin at the joint rear corner Lots Nos. 36, 37, 19 and 20; thence along the rear line of Lots Nos. 19 and 18, S. 9-56 E. 160 feet to an iron pin at the joint rear corner of Lots Nos. 17, 18, 38 and 39; thence along the joint line of Lots Nos. 38 and 39, N. 80-04 E. 175 feet to an iron pin on the western side of Charles Drive at the joint front corner of Lots Nos. 38 and 39; thence along the western side of Charles Drive, N. 9-56 W. 160 feet to the beginning corner.
