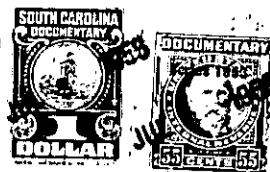

ALL that piece, parcel or tract of land with all improvements thereon, situate, lying and being in Saluda Township, Greenville County, State of South Carolina, being known and designated as Lots 30 and 31, Section 3, of a subdivision known as "Lazy City" according to a plat thereof, recorded in the RMC Office for Greenville County, S. C., in Plat Book "BB", page 67, reference to which plat is hereby craved for a more particular description.

THIS is the same property conveyed to the Grantors by deed of Lazy City, Inc., dated September 23, 1952, recorded in the RMC Office for Greenville County, S. C., in Deed Book 469, at page 71.

ALSO all interest which the Grantors have in and to any lands lying within the boundaries of any road or street, adjacent to, bounding or running through the above described property.

ALSO all interest which the Grantors have in or to any lake and strip of land adjacent thereto and any right the Grantors have to use and enjoy the same, adjoining the above described property in Lazy City.

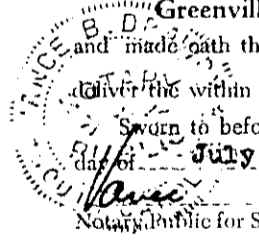

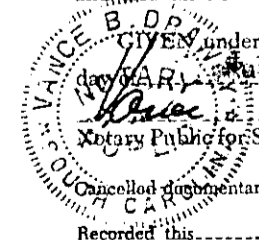
