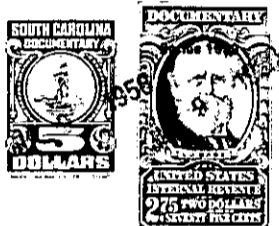
All that certain piece, parcel or lot of land lying and being on the Westerly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 10 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Selwyn Drive, joint front corner of Lots Nos. 9 and 10, and running thence along the common line of said lots N. 74-34 W 231.6 feet to an iron pin; thence S 47-58 W 71 feet to an iron pin; thence S 5-44 E 94.8 feet to an iron pin, joint rear corner of Lots Nos. 10 and 11; thence along the common line of said lots S 88-25 E 248 feet to an iron pin on Selwyn Drive; thence along the Westerly side of Selwyn Drive N 11-26 E 90 feet to the point of beginning.
