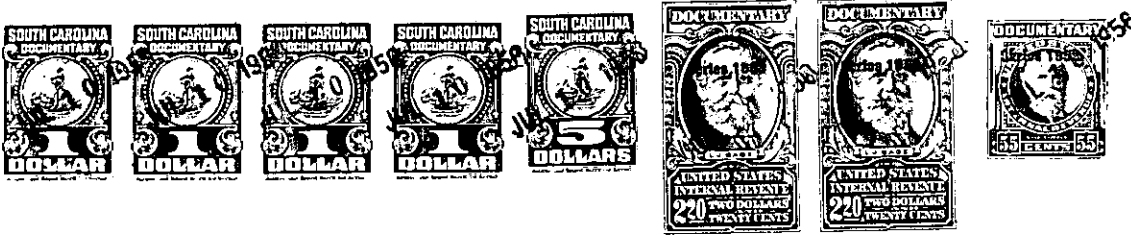
That WE, R. M. GAFFNEY, CHARLES E. ROBINSON, JR. & JOHN F. CHANDLER

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mordecai Nachman and Charlton P. Armstrong, Jr., Trustees for the Urological Clinic, Inc., a proposed corporation

ALL that lot of land situate on the East side of South Carolina Highway 291 near the City of Greenville, in Butler Township, Greenville County, S. C., being a portion of Lot No. 1 as shown on plat of property of J. H. Sitton made by Piedmont Engineering Service April 13, 1955, recorded in the RMC Office for Greenville County, S. C., in Plat Book "II", at page 127 and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of South Carolina Highway 291, said pin being 10 feet North from the joint front corner of Lots No. 1 and 2 and running thence through Lot No. 1 S. 88-15' E. 179.9 feet to an iron pin on the West edge of a 30 foot service alley; thence along the West edge of said alley N. 0-43 E. 29.55 feet to an iron pin; thence S. 88-42 W. 179 feet to an iron pin on the East side of South Carolina Highway 291; thence with the East side of said highway S. 1-45 W. 20 feet to the beginning corner.
