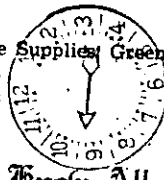

Know All Men by These Presents:

That We, W. C. Stewart and Ruth Stewart, in consideration of the sum of One and no/100 (\$1.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Greenville County, its successors and assigns forever to be used for street purposes,

All that piece, parcel or lot of land situate, lying and being on the Southern side of Crescent Ridge near the City of Greenville, County of Greenville, State of South Carolina, and shown on a plat prepared by Woodward Engineering Company, March, 1956, as Saul Road, and according to said plat having the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southern side of Crescent Ridge at its intersection with Saul Road which iron pin is 434.6 feet East of the intersection of Crescent Ridge and Pleasantburg Drive, running thence in a curved line the chord of which is S. 58-12 E. 27.4 feet to an iron pin on the Western side of Saul Road; running thence the following courses and distances along the outside boundaries of the said Saul Road S. 9-28 E. 356.1 feet to an iron pin, S. 12-15 E. 46.1 feet to an iron pin, S. 16-15 W. 49.4 feet to an iron pin, S. 38-09 E. 71.4 feet to an iron pin, N. 31-51 E. 70.3 feet to an iron pin, N. 43-09 W. 50.4 feet to an iron pin, N. 12-15 W. 47.3 feet to an iron pin, N. 9-28 E. 348.7 feet to an iron pin at the intersection of Saul Road and Crescent Ridge which intersection is curved, the chord of which is N. 39-48 E. 26 feet to an iron pin on the Southern side of Crescent Ridge; running thence S. 88-54 W. 76.6 feet to an iron pin; running thence S. 77-05 W. 70 feet to an iron pin, point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and its Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
