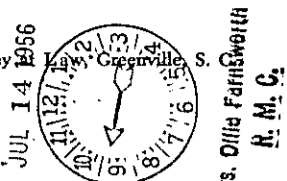

Jones made by Dalton and Hives in April, 1954, and being designated on said plat as Cornell Court Extension, Lewis Street and Farley Drive (the name of said Farley Drive, as shown on said plat, to be changed to Acacia Drive).

It is understood that this property is to be used as a public road.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors, Heirs and Assigns forever.
