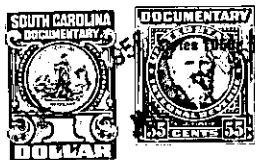

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Willis E. Case her Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, just outside the corporate limits of the Town of Fountain Inn, in the subdivision known as Woodland Heights, being known and designated as Lot No. 33 of the Lilla H. Jones & Essie Mae H. Jones property on a Plat prepared by Lewis C. Godsey, Surveyor, in May 1954, said Plat of record in the Office of the R. M. C. for Greenville County, S. C., in Plat Book "E E" at page 101, and having the following metes and bounds, to-wit: Beginning at an iron pin on the East side of Woodland Drive, joint front corner with Lot No. 32, running thence with the joint line of said Lot No. 32 S. 78-15 E. 254 feet to an iron pin in or near branch, back joint corner with said Lot No. 32; thence with the branch S. 0.16 E. 76.6 feet to an iron pin, back joint corner with Lot No. 34; thence with the joint line of said Lot No. 34 N. 78-15 W. 270.8 feet to an iron pin on Woodland Drive, joint front corner with said Lot No. 34; thence along the East side of said Woodland Drive N. 14-00 E. 45 feet to an iron pin; thence continuing along the East side of said Drive N. 10-00 E. 30 feet to an iron pin, the point of beginning.
