to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) William Donald Owens and Stella G. Owens and their heirs and assigns forever:

All that certain parcel or lot of land situated on the south side of Mountain View Avenue in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, being Lot No. 26 of the Property of W. Dennis Smith and H.J. Waters according to survey and plat by H.S. Brockman, Surveyor, dated June 8, 1950, recorded in Plat Book Y, page 69, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning at an iron pin on south side of Mountain View Avenue, corner of Lots Nos. 25 and 26, and running thence along line of same, S. 8.35 W. 146.1 feet to an iron pin; thence S. 77.15 E. 70 feet to an iron pin, corner of Lot No. 27; thence along line of same, N. 8.35 E. 150.1 feet to an iron pin on south side of said avenue; thence along said avenue, N. 81.25 W. 70 feet to the beginning corner.
