to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James A. Boling, his Heirs and Assigns, forever:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, situate, lying and being on the Northern side of Barbara Avenue, being shown and designated as Lot No. 279 on Plat of the property of Robert J. Edwards recorded in the R.M.C. Office for Greenville County in Plat Book EE, at page 61, and having, according to said Plat; the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Barbara Avenue, at the joint front corner of Lots Nos. 278 and 279, and running thence with the line of Lot No. 278, N. 47 W. 300 feet to an iron pin in the rear line of Lot No. 268; thence with the rear line of Lots Nos. 268 and 269, N. 43 E. 172.7 feet to an iron pin in the rear line of Lot No. 243; thence with the joint line of Lots Nos. 243, 242 and 241, S. 33-30 E. 308.6 feet to an iron pin on Barbara Avenue; thence with the Northern side of Barbara Avenue, S. 43 W. 101 feet to the point of beginning.

It is understood that this conveyance is made subject to restrictive covenants recorded in the R.M.C. Office for Greenville County in Deed Book 505, at page 291, which are applicable to all lots shown on said Plat.
