in consideration of the sum of One Hundred Thirty-two and No/100-----(\$132.00)--- in the State aforesaid, DOLLARS,

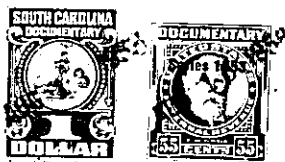
