Hackett and her heirs and assigns forever:

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, in the City of Greer, located on the South side of Springdale Avenue, formerly Spring Street, being known as Lot No. 81 on a plat of property made for N.M. Cannon by H.S. Brockman, Surveyor, January 16, 1924, R.M.C. Office for Greenville County, and having the following courses and distances:
