to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto S. W. CREECH, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 114, Section II, Lake Forest Subdivision, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "EE", page 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Hermitage Road, joint front corner Lots 113 and 114, and running thence N. 86-31 W. 180 feet to an iron pin, joint rear corner Lots 113 and 114; thence S. 3-29 W. 106.3 feet to a point in a branch; thence with the branch as the line, the traverse line being S. 72-25 E. 185.6 feet to a point on Hermitage Road; thence along Hermitage Road N. 3-29 E. 151.5 feet to an iron pin, the point of beginning.

ALSO

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 123, Section III, Lake Forest Subdivision as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 77, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the curve of Hermitage Road, joint front corner Lots 123 and 124, and running thence S. 72-59 W. 330.6 feet to a point in a branch; thence with the branch as the line, the traverse line being N. 23-08 E. 305.3 feet to a point in another branch; thence with the said branch as the line, the traverse line being S. 72-25 E. 185.6 feet to a point on Hermitage Road; thence along Hermitage Road S. 8-32 E. 129.4 feet to an iron pin, the point of beginning.

The above-described property is conveyed subject to certain recorded and existing building restrictions, easements and rights-of-way.

The grantee herein is to pay the 1956 taxes on the above-described property.
