All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 124, Section III, Lake Forest Subdivision, as per plat thereof recorded in the P.L.O. Office for Greenville County, South Carolina, in Plat Book "33", page 77, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Hermitage Road, joint front corner Lots 123 and 124, and running thence S. 72-59 W. 330.8 feet to a point in a branch; thence with the branch as the line, the traverse line being S. 27-28 W. 221.3 feet to a point in the said branch; thence N. 69-09 E. 572.3 feet to an iron pin on Hermitage Road; thence along the curve of Hermitage Road, the chord of which is N. 73-10 W. 97.7 feet and N. 34-53 E. 64.6 feet to an iron pin, the point of beginning.
