That I, Lee C. Green in the State aforesaid, in consideration of the sum of EIGHTY (\$80.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

Joe R. Henderson, his heirs and assigns forever:

All that piece, parcel or lot of land in O'Neal Township, County of Greenville, State of South Carolina, located on the West side of State Highway No. S 135, and being shown as lot number SEVEN (7) on a plat entitled "WASHINGTON HEIGHTS" made by H. S. Brockman, surveyor, dated July 31, 1956 and recorded in plat book LL page 55, Greenville County R. M. C. Office and having the following metes and bounds according to said plat.

Beginning at a stake on the West side of said highway at the joint front corner of lots 7 and 8 and running thence N. 9-00 E., 100 feet along said highway to a stake at the corner of lot 6; thence N. 73-26W., 229.7 feet to a point on the line of lot 16; thence S. 14-55 W., 100 feet to a point on the line of lot 15; thence S. 73-39 E., 240.4 feet to the beginning corner. This is a part of the property willed to me by my father, J. B. Green ( see estate probated in Apt. 284 file 1, Greenville County Probate office) by item two of said will.

The within property is subject to the following restrictions:

- 1. That no dwelling or other building shall be erected any closer than 40 feet to the street or road on which the property fronts.
2. That no alcoholic beverages shall be sold on the property.

These restrictions shall run with the land and shall be binding on the within grantee and all persons claiming under him for a period of 21 years.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
