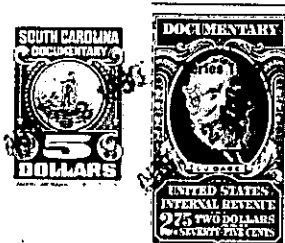


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY

Philpot and Norris Newton, the same as shown on a plat thereof prepared by Piedmont Engineering Service, Greenville, South Carolina, dated December 28, 1955. Said plat being recorded in the R. M. C.
