ALL that certain parcel or tract of land in Grove Township, County of Greenville, State of South Carolina containing 4.26 Acres, more or less and being designated as Tract No. 9 as shown on the plat of the property of L. W. Young, dated April, 1955, by C. O. Riddle, Registered Surveyor as recorded in Plat Book No. II Page 119 Office of the R. M. C. for Greenville County, the said tract being more particularly described by metes and bounds as follows:

BEGINNING at an iron pin at the joint corner of Tracts 8 and 9, and running N. 35-00 W., 419.1 Feet to an iron pin; thence N. 61-30 E., 277 Feet to an iron pin; thence N. 86-30 E., 396 Feet to an iron pin, designated on the Plat as W. O.; thence S. 2-10 E., 189 Feet to an iron pin; thence S. 59-30 W., 132 Feet to an iron at the common corner of Tracts 8 and 9; thence along the common line of Tracts 8 and 9, S-54-50 W., 378.3 Feet to the point of Beginning.
