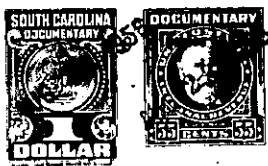

That I, ED BLACK, in the State aforesaid, in consideration of the sum of Two hundred Ninety-five and no/100 (\$295.00) - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, S. C., its successors and assigns, forever:

ALL that piece, parcel or tract of land situate, lying and being in Saluda Township, Greenville County, State of South Carolina, located just off the present U. S. Highway 25, being known and designated as Lot 47, Block A, Plat 2 of Bonaire Heights Park according to a plat thereof recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "EE", pages 39 and 41, and having, according to said plat, the following description:

BEGINNING on the East side of Laurel Drive, at joint corner of Lots 46 and 47, and running thence along the Eastern side of Laurel Drive, S. 7-54 W., 55 feet to the joint corner of Lots 47 and 48; thence along the joint line of those two lots, S. 80-13 E., 183.9 feet to corner; thence N. 14 E., 45 feet to joint rear corner of Lots 46 and 47; thence along the joint line of those two lots, N. 77-16 W., 192.4 feet to the Beginning corner on the Eastern edge of Laurel Drive.

This is the same property conveyed to the Grantor herein by deed of H. O. Padrick, Jr., as Trustee, dated June 30, 1956, to be recorded herewith.

ALSO all interest which the Grantor has in and to any lands lying within the boundaries of any road or street, adjacent to, bounding or running through the above described property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
