to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

ALL that piece, parcel or tract of land situate, lying and being in Saluda Township, Greenville County, State of South Carolina, located just off U. S. Highway No. 25, being known and designated as Lot No. 33, Block A, Plat No. 1 of Bonaire Heights Park, according to a plat recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "E", pages 39 and 41, and having according to said plat the following metes and bounds:

BEGINNING at the joint corner of Lots 32 and 33 on the Southern side of Laurel Drive, and runs thence along the Southern side of Laurel Drive N. 63-05 W. 55 feet to joint corner of Lots 33 and 34; thence along the joint line of those two lots S. 13-32 W. 215 feet to corner; thence N. 81 E. 73 feet to joint rear corner of Lots 33 and 32; thence along the joint line of those two lots N. 9-45 E. 193.7 feet to the beginning corner.
