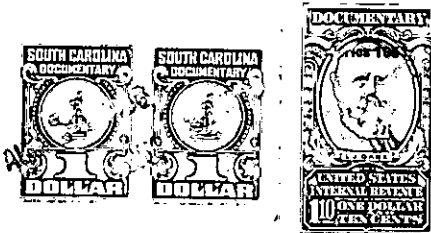
Evelyn H. Aiken, her heirs and assigns forever:
