**RULES AND REGULATIONS OF**

**GRACELAND CEMETERY DEVELOPMENT CO., INC.**

**1. RULES GOVERNING CEMETERY LOT OWNERSHIP.** Lots purchased in Graceland Cemetery are conveyed by Warranty Deed to the purchaser for his family and heirs as a burial place forever.

In order that the Corporation may have a correct record of ownership of lots which are to be conveyed to a purchaser, it is required that the recorded deed shall be presented to the office so that a record of transfer can be made. A fee of \$2.00 will be collected before any transfer of ownership is made on the Corporation's records. The Corporation is governed by its own records as to ownership of lots.

When a lot is purchased and an extension of time is granted by the Corporation for payment, the Corporation retains ownership of the lot until all charges due it are paid, and the Corporation reserves the right to remove the remains which may be interred on the lot, to a smaller lot equal in value to the amount paid on the original lot, or to a suitable grave in the event that a default occurs in the agreed payment.

An order in writing is required of the lot owner when a grave is to be opened, containing the name, age, sex and residence of the deceased, and a permit from the Board of Health must be shown the Superintendent of the grounds before interment is made. If interment is to be made in the forenoon, application must be made before 2 o'clock p. m. on the previous day. If in the afternoon, by 9 o'clock a. m. on the same day.

Lot owners shall at once notify the Corporation of any change in his or her post office address or name. No interment shall be allowed except upon order of the Executive Officers of the Corporation, and upon the written order of the owner or owners of the lot, and in every case can only be made under the supervision of the Superintendent.

The Corporation shall have the right at all times to enter upon each and every lot for the purpose of maintaining, cleaning, and releveling it. The Corporation from time to time may lay out or alter such avenues or walks, or make such releveling and grading for the government of the grounds as it may in its discretion or in order to promote the general objects of the cemetery.

No contract or approval of the Corporation shall be valid or binding unless the same shall be in writing over the signature of an Executive Officer. **RULES GOVERNING WORK DONE AT CEMETERY.** All orders for work should be left with the Superintendent who is located on the Cemetery property. Work is not to be done on the grounds for work or for any other purpose until the payment of the cost of the work has been made in full.

No lot owner shall have the right to have shrubs and plants set out on any part of the lot except by order of the Corporation. In the case of plants set out by lot owners, the Corporation shall be held responsible for the death of the same. No improvement shall be made on monument, effigy, or structure of any kind on any lot or grave without the consent of the Corporation. No work of any character will be done upon any lot except by order of the Corporation, and no work shall be done on any lot or grave without the consent of the Corporation.

The grade of all lots, lawns, and avenues as established, or changed, from time to time, by the Corporation and all improvements put or placed upon any lot shall not be altered or changed except by the Corporation. No trees, shrubs, or plants shall be placed upon or removed from any lot or grave, except with the consent of the Corporation, but the Corporation shall have the right, from time to time, to plant, transplant, remove, or trim trees, shrubs, and plants upon said lots.

The Corporation reserves to itself the entire control of every tree, shrub, or vine growing within the cemetery enclosure, whether planted by the lot owner or otherwise, including the right of removal when it comes to its removal advisable. Trees will not be removed to make additional burial space.

The Corporation will use reasonable care in examining trees and removing those apparently in unsound and dangerous condition or unsound and dangerous limbs and branches of trees, but it expressly disclaims responsibility for damage either to persons or property in such cases from falling trees or parts of trees. No flowers or ornaments or objects shall be kept upon any lot after the same shall have become withered, soiled or unsightly and in case of the failure of the owner of any lot to remove any such flowers or other unsightly objects the Corporation shall have the right to remove the same and in no case will the Corporation attempt to be responsible for anything placed on lots or graves.

No back-slash, glass covering, wire, metal arches, wire, iron pipes, glass cases, covering, or any other artificial flow, or any sort of receptacle for flowers, except such as may be used below the surface of the lawn for the grave or lot containing a casket, or any other object which may be lifted out while moving the said lot, shall be placed on any grave or lot and all such objects are not to be placed on the surface of the lawn, grave, or lot, nor be removed by the Corporation.
