

BEGINNING at an iron pin on the Western side of a 5-foot sidewalk running along Darlington Avenue, said pin being the joint front corner of Lots Nos. 9 and 10, and running thence along said sidewalk N. 43-0 E. 32 feet to an iron pin in the front lot line of Lot No. 10; running thence along a new line through Lot No. 10 N. 40-20 W. 48.2 feet to an iron pin; running thence S. 84-28 E. (should read N. 84-28 W.) 49.2 feet to an iron pin, joint rear corner of Lots Nos. 9 and 10; running thence along the joint lines of said lot S. 47-0 E. 80 feet to an iron pin, the point of beginning.
