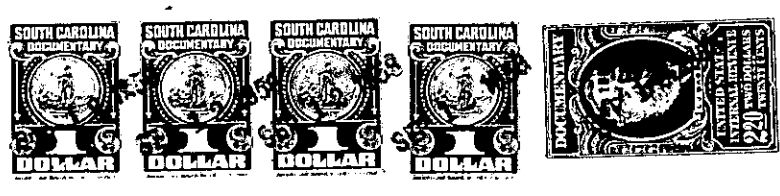
Clifford W. Liles, his heirs and assigns forever: .
