TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS; That Caesar's Head Company, Inc., a corporation chartered under the laws of the State of South Carolina and having a place of business and owning property in the aforesaid County and State of South Carolina, for and in consideration of the sum of Two Thousand and No/100 (\$2,000.00) Dollars to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto JOHN T. GIBBS, his heirs and assigns:

All that certain piece, parcel or lot of land, situate, lying and being in Cleveland Township, Greenville County, State of South Carolina, at or near Caesar's Head, and having according to a recent survey and plat entitled "Property of Caesar's Head Co., Inc" prepared by J. D. Calmes, Reg. Surveyor, August 18, 1956 (to be recorded herewith) the following metes and bounds, to-wit:

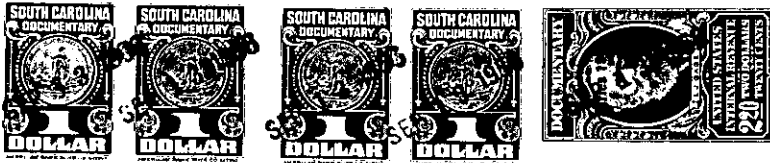
BEGINNING at the southwest intersection of Sunrise Drive and an unnamed Drive and running thence S. 30-50 W. 100 feet to an iron pin; thence N. 59-10 W. 55 feet to an iron pin; thence N. 30-50 E. 100 feet to an iron pin on unnamed Drive; thence S. 59-10 E. 55 feet to point of beginning.

This conveyance is made, however, subject to the following restrictions which are deemed covenants running with the land:

- (1) This property may be used for residential purposes only and no building other than a one-family dwelling may be erected thereon, garage and outbuildings excluded.
(2) No hotel, inn, boarding house, cafe, restaurant or any type of eating establishment may be erected or operated on these premises.

This property is conveyed subject to any existing rights-of-way or easements for utility purposes.

The plat above referred to is recorded in the R. M. C. Office for Greenville County in Plat Book LL, Page 93, and the above described lot is shown on said plat as "Cottage #2".



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his (her or their) heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
