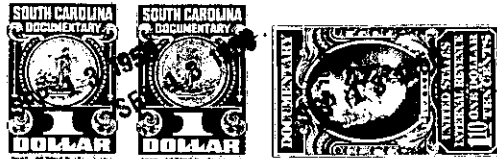
F. E. Albright and Lola K. Albright, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southerly side of East Lee Road, at the southeasterly corner of its intersection with Bedford Drive, near the Town of Taylors, S. C., being shown as Lot No. 17 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of East Lee Road, joint front corner of Lots Nos. 17 and 18, and running thence along the southerly side of said Road N 83-06 W 75.14 feet to an iron pin at the intersection of said Road with Bedford Drive; thence around said intersection on a curve, the chord of which is S 53-24 W 36.2 feet to an iron pin on the easterly side of Bedford Drive; thence along the easterly side of said Drive S 9-54 W 175 feet to an iron pin, joint corner of Lots Nos. 17 and 19; thence along the joint line of said Lots S 80-06 E 100 feet to an iron pin, joint rear corner of Lots Nos. 17 and 18; thence along the joint line of said Lots N 9-54 E 205.2 feet to the point of beginning.
