Know All Men by These Presents:

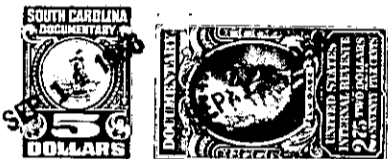

Gaffney, in the State aforesaid, in consideration of the sum of Twenty-Three Hundred Seventy-Five and no/100 (\$2,375.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. C. Haskell and James H. Robinson, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the easterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 29 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Selwyn Drive at a point 750 feet north of the northeasterly corner of the intersection of Selwyn Drive and Spartanburg Road, said pin being the joint front corner of Lots Nos. 28 and 29, and running thence along the joint line of said Lots N 84-16 E 253.8 feet to an iron pin in the line of Lot No. 40; thence along the line of Lot No. 40 N 2-03 E 64.9 feet to an iron pin, joint rear corner of Lots Nos. 29 and 30; thence along the joint line of said Lots S 89-56 W 264 feet to an iron pin on the easterly side of Selwyn Drive; thence along the Easterly side of said Drive S 5-44 E 90 feet to the point of beginning.

This is part of the property conveyed to the grantor by deed recorded in Deed Book 528, page 103, and this conveyance is made pursuant to the authority and powers granted the Trustee in said deed.
