in consideration of the sum of One Hundred Twenty-two and No/100----- in the State aforesaid, DOLLARS,

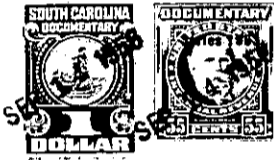
