Highway No. 291, said pin being ten feet North from the joint front corner of Lots Nos. 1 and 2 and running thence through Lot No. 1, S. 88-15 E. 179.9 feet to an iron pin on the West side of a thirty foot service alley; thence along the Western edge of said alley, N. 0-43 E. 29.55 feet to an iron pin; thence S. 88-42 W. 179 feet to an iron pin on the Eastern side of S. C. Highway 291; thence with the Eastern side of said Highway S. 1-45 W. 20 feet to the beginning corner.
