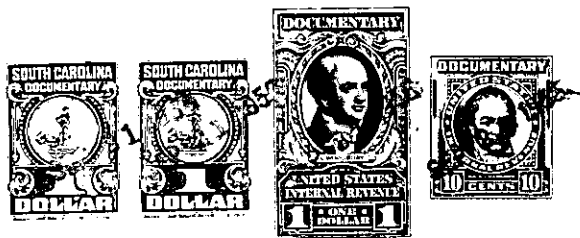
J. O. Estes, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the Westerly side of Whitman Drive, near the Town of Taylors, S. C., being shown as Lot No. 53 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Whitman Drive at a point 250 feet north of the northwesterly corner of the intersection of Whitman Drive and Heathwood Drive, said pin being the joint front corner of Lots Nos. 52 and 53, and running thence with the line of said lots N 80-06 W 210 feet to an iron pin in the line of Lot No. 63; thence N 9-54 E 100 feet to an iron pin, joint rear corner of Lots Nos. 53 and 54; thence with the joint line of said Lots S 80-06 E 210 feet to an iron pin on the westerly side of Whitman Drive; thence along the westerly side of Whitman Drive S 9-54 W 100 feet to the point of beginning.
