

ALL that lot of land with the buildings and improvements thereon, situate on the Northwest side of Lenore Avenue, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 128 on Map No. 3 of Sans Souci Heights, made by W. J. Riddle, Surveyor, November, 1950, recorded in the R.M.C. Office for Green-ville County, S. C., in Plat Book "Z", at Page 95, and having, according to said plat, the following metes and bounds, to wit:
