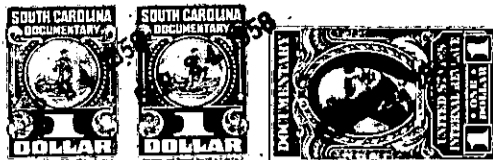

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **Barbara Ann Garrett Boggs, her heirs and assigns, forever:**

All that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 28 on Plat of Avalon Estate, recorded in the RMC Office for Greenville County in Plat Book "S", at page 89, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the Western side of Crestview Drive at the joint front corners of Lots 27 and 28 and running thence with the joint line of said Lots, S. 77-39 W. 160 feet to an iron pin; thence N. 12-21 W. 60 feet to iron pin; thence along the joint line of Lots 28 and 29, N. 77-39 E. 160 feet to iron pin on the western side of Crestview Drive; thence with Crestview Drive S. 12-21 E. 60 feet to the beginning corner.

This conveyance is subject to all easements and rightsofway of record.

This conveyance is subject to the covenants, conditions and restrictions recorded in the RMC Office for Greenville County in Vol. 495, at page 523.

Grantee to pay 1956 taxes.

It is expressly understood by the parties hereto that this deed has been executed pursuant to a Contract of Sale heretofore entered into between the parties. However the South Carolina Highway Department has condemned the major portion of this lot for highway purposes and this deed is executed with full knowledge of said condemnation, to complete the title and to vest the remaining part of said lot in the Grantee.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and **her** Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every per on whom-oever lawfully claiming or to claim the same or any part thereof.
