All that lot of land in Greenville County, State of South Carolina, on the East side of Curtiss Drive, near the City of Greenville, being shown as lot # 9, on a plat of the property of Horace A. Pulliam, recorded in Flat Book JJ at Page 193, and described as follows:

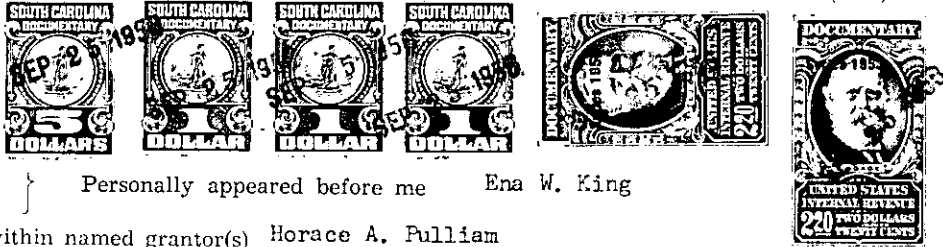
