BEGINNING at an iron pin at joint front corner of lots #4 and #5, on the Northern side of Sevier Court, running thence along the line of these lots, N. 1-50 E. 109.9 feet to an iron pin, thence S. 88-10 E. 80 feet to an iron pin, thence S. 1-50 W. 150 feet to an iron pin on the Eastern side of Sevier Court, which line is curved, the chord of which is N. 48-27 W. 64.2 feet to an iron pin, thence continuing along Sevier Court, S. 68-12 W. 40 feet to an iron pin, point of beginning.

Note: All lots facing turn around are subject to 50' easement from radius point. Easement is to be abandoned upon extension of Sevier Court.
