Riddle, dated August 1956, and having, according to said plat, the following courses and distances, to-wit: BEGINNING at a stone on the line of property now or formerly belonging to Roy Meeks and/or Richey and running thence NL7 E 20.80 chains to a stone; thence S 60 E 7 chains to a stone; thence N 27-15 E 9.75 chains to a point on Reedy Fork Creek; thence up the Creek, with the Creek as a line to a point in said Creek on line of W.
