, has been given that the aforesaid Declaration would be filed.

FIRST: Their names and residences are as above given.

SECOND: The name of the proposed Corporation is GREENVILLE COUNTY COON HUNTERS! ASSOCIATION

THIRD: The place at which it proposes to have its headquarters or be located is Travelers Rest, S. C.

FOURTH: The purpose of the said proposed Corporation is to preserve and protect the coons of Greenville County and preserve other wild life.
