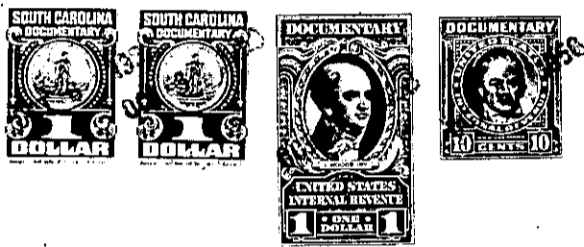
Know All Men by These Presents:

Rudd, his heirs and assigns, forever:-

all that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, Bates Township, town of Marietta, on the E/S of Duff Ave., adjoining lands of Patsy and Dewey Bishop, E.S. Guest, E.J. Avant and Duff Ave., and having the following metes and bounds, courses and distances, to-wit:

BEGINNING at the joint corners this land and that of Bishop on the E/S of Duff Ave. and running with said avenue S 26 E 150 feet to an iron pin; thence N 64 E 140 feet to an iron pin; thence N 26 W 145 feet to an iron pin on the Bishop line; thence with Bishop line S 60-45 W 140 feet to the beginning corner.
