Meyer Lurey, his heirs and assigns forever:

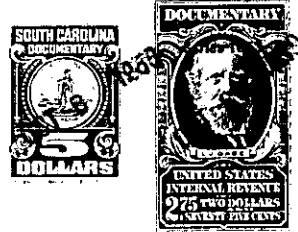

BEGINNING at an iron pin on the westerly side of Bedford Drive at a point 186.5 feet north of the northwesterly corner of the intersection of Bedford Drive and Heathwood Drive, and being the joint front corner of Lots Nos. 33 and 34, and running thence along the joint line of said Lots N 80-06 W 200 feet to an iron pin; thence N 9-54 E 300 feet to an iron pin, joint rear corner of Lots Nos. 36 and 37; thence along the joint line of said lots S 80-06 E 200 feet to an iron pin on the westerly side of Bedford Drive; thence along the westerly side of said Drive S 9-54 W 300 feet to the point of beginning.
