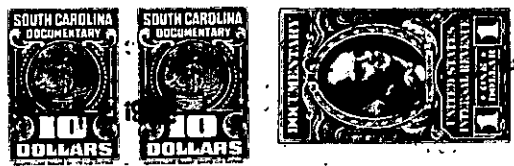

Know All Men by These Presents:

That I, B. R. O'Neall, in the State aforesaid, in consideration of the sum of Seven Thousand Four Hundred Thirty-six & 75/100 (\$7436.75) DOLLARS, and exchange of property valued at \$2,463.25 to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ruey E. Bowers and Earline C. Bowers ALL That certain piece, parcel or lot of land with the building and improvements thereon, situate, lying and being on the Northeast side of Edgewood Drive, near the City of Greenville, S. C., being shown as Lot No. 1 on plat of property of B.R. O'Neall, prepared by C. C. Jones & Associates, Engineers, dated March 1955, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book JJ, Page 166, and being more particularly shown on plat of property of Ruey E. Bowers and Earline C. Bowers, dated October 6, 1956, prepared by C. C. Jones & Associates, Engineers, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the Northeast side of Edgewood Drive, at the joint front corner of Lots 1 and 2, which iron pin is 631 feet from the intersection of Edgewood Drive and Mills Ave., and running thence along the joint line of Lots 1 and 2, N. 47-23 E. 167.4 feet to an iron pin, joint rear corner of said lots; thence turning and running N. 34-34 W. 8.9 feet to an iron pin; thence N. 50-29 W. 61.1 feet to an iron pin on the Southeast side of an unnamed 20-foot street; thence along the Southeast side of said unnamed 20-foot street, S. 45-14 W. 176.2 feet to an iron pin on the Northeast side of Edgewood Drive; thence along the Northeast side of Edgewood Drive, S. 56-49 E. 65 feet to the point of beginning.

Being a part of the same property conveyed to me by Otis P. Moore and James P. Moore by deed dated March 11, 1955, recorded March 12, 1955, in the Office of the R.M.C. for Greenville County, S. C. in Deed Book 520 at Page 290.

This property is subject to restrictions and existing easements.
