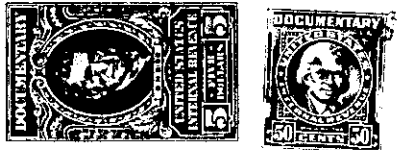
Know All Men by These Presents:

All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, Adjoining the lands now or formerly owned by Furman Pritchett, Charley Laws, Florence Story.

Beginning on a iron pin on Settlement Road(now Southerlin Road) and running thence N.85 E. 1.00 chs. to a bend in road; thence S. 47 E. 2.30 to a iron pin in fork of road; thence N. 75 W. 2.31 chs. to a iron pin; thence N. 13 W. 3.33 to the beginning corner and contains 52/100 of an acre, more or less.

Also, all that piece, parcel or lot of land lying situate and being in Cleveland Township, Greenville County, State of South Carolina, adjoining the lands described above, W. M. Laws and others.
