ROBERTS, her heirs and assigns:

A one-half interest in and to all that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, near Paris Station, and being known and designated on Plat of Paris Heights Subdivision as lot marked "S", Block "B", and being shown on Plat of W. A. Sanders recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "S", page 149, as the rear portion of Lots 31 and 32, and having, according to said plat, the following metes and bounds, to-wit:
