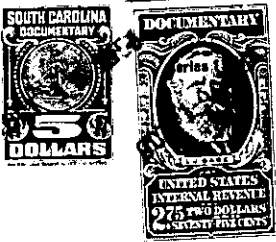
KNOW ALL MEN BY THESE PRESENTS That More, Inc.,
