

Know All Men by These Presents:

in the State aforesaid, K, Hr That I, Theodore Newton DOLLARS, in consideration of the sum of Eight Hundred and no/100 (\$800.00) and assumption of mortgages to the granter(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Kelly Turner and Irvin E. Turner, their heirs and assigns:

All those two lots of land in Gantt Township, Greenville County, South Carolina being known and designated as Lots Nos. One and Two (1 and 2) of Oak Ridge Heights according to a plat made by C. C. Jones, January 17, 1951, and recorded in the R. M. C. Office for Greenville County in Plat Book "Y" at Page 67, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the Eastern side of the Piedmont Highway (US 29) at the Northern corner of the intersection of said Highway with Helen Drive and running thence with Helen Drive S. 77-45 E., 386.5 feet with the line of Lots Nos. 1 and 2 to a pin at the corner of Lots Nos. 2 and 3 on the Eastern side of said Drive; thence with the lines of Lot No. 3, N. 12-15 E., 66 feet to a pin; thence with the lines of Lots Nos. 1 and 2, N. 77-45 W., 400 feet to a pin on the Eastern side of said Highway; thence with the Eastern side of said Highway S. 0-45 W., 67.4 feet to the beginning corner.

This is the same property conveyed to Theodore Newton by H. B. Gosnell by his deed dated May 22, 1956 and recorded in the Greenville County R. M. C. Office in Book 561 at Page 375.

The grantees assume payment of two mortgages, having an aggregate present balance of Forty Seven Hundred (\$4,700.00) Dollars. The first mortgage is to Lila E. Earle, executrix, having a balance of Fifteen Hundred (\$1,500.00) Dollars, and recorded in Vol. 592 at Page 224. The second mortgage is to H. B. Gosnell in the sum of Forty Two Hundred (\$4,200.00) Dollars, and is recorded in Vol. 691 at Page 296.
