That I, ERNEST R. GOODMAN, in consideration of the sum of One Hundred Fifty-five and No/100----- in the State aforesaid, DOLLARS,

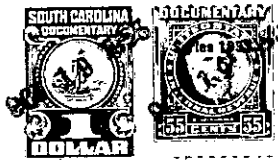
