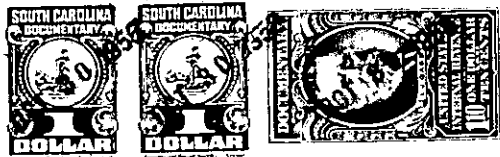

STEVENS & CO., INC. owning property and having a corporation chartered under the laws of the State of Delaware and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Nine Hundred and Fifty (\$950.00) dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto ALVIN O. ANDERSON AND LOUVENIA H. ANDERSON

All that piece, parcel or lot of land situate, lying and being at the Southwestern corner of Lindsay Street and Marchant Street near Monaghan Mills in the County of Greenville, State of South Carolina, and known and designated as Lot 9 as shown on a plat entitled "Monaghan Subdivision, Greenville, S. C." made by Piedmont Engineering Service, Greenville, S. C., August 9, 1954, and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Marchant Street at the joint front corner of Lots 8 and 9, and running thence along the Southern side of Marchant Street N. 84-43 E. 81.9 feet to an iron pin; thence in a curved line (the chord of which is S. 48-12 E. 34.1 feet) to an iron pin on the Western side of Lindsay Street; thence along the Western side of Lindsay Street S. 1-08 E. 243.3 feet to an iron pin at the Northeastern corner of Lot 2; thence with the rear line of Lot 2 S. 74-13 W. 65.1 feet to an iron pin at the joint rear corner of Lots 8 and 9; thence with the common line of said two lots N. 10 15 W. 280.2 feet to an iron pin, the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision recorded in the R. M. C. Office for Greenville County in Deed Book 509, at page 443, and to an easement for utilities service dated October 11, 1954, given by J. P. Stevens & Co., Inc., to Duke Power Company and recorded in the R. M. C. Office for Greenville County in Deed Book 510 at page 317.

This conveyance is also made subject to an easement for a high tension power line across the Southern part of the above-described lot, as shown on the afore-mentioned plat.



Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, their heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and their heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

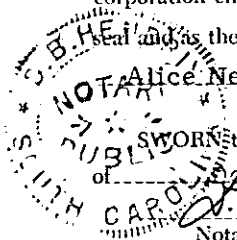
