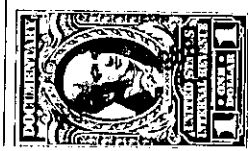
All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 13 on Plat of Property of Central Development Corporation, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "BB", pages 22 and 23, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Alpine Way, joint corner Lots 12 and 13 and running thence N. 54-37 W. 150.9 feet to an iron pin, joint rear corner Lots 12 and 13; thence S. 39-19 W. 75 feet to an iron pin, joint rear corner Lots 13 and 14; thence S. 55-14 E. 173.3 feet to an iron pin on the Westerly side of Alpine Way, joint front corner Lots 13 and 14; thence along the Westerly side of Alpine Way N. 21-58 E. 75 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given The First National Bank, as Executor, on which there is a balance due of \$7,087.50; said mortgage being recorded in Mortgage Volume 657, page 368.
