(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
these presents do grant, bargain, sell and release unto the said H. D. Wilson and
Edna Wilson Rivers, hereby reserving unto myself the right to use
and enjoy said property until my death,

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina at the northwestern intersection of Super
U. S. Highway No. 29 and Artillery Road, being shown as Lot No. 17
on plat of property of Vance Edwards and Robert J. Edwards, made by
Dalton and Neves, Engineers, in September, 1940, and having accord-
ing to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the northwest side of Super U. S. Highway
No. 29, at corner of Lot No. 18, and running thence with the line of
said lot, N. 30-30 W. 224.5 feet to iron pin in line of Lot No. 16;
thence with the line of said lot, N. 35-37 E. 107 feet to iron pin
on Artillery Road; thence with the western side of Artillery Road,
S. 30-30 E. 172 feet to iron pin; thence with the curve of Artillery
Road, S. 4-15 E. 76 feet to iron pin; thence continuing with
Artillery Road, S. 36-10 W. 70 feet to the beginning corner.

Greenville County, State of South Carolina 5 miles from Greenville
County Court House on the Northwestern side of Super Highway No. 29
