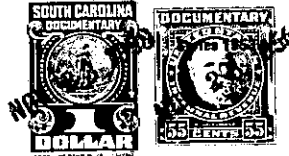

BRYAN WHITMIRE, His Heirs And Assigns,

ALL that certain piece, parcel or lot of land located in Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot No. 9 as located on Elaine Drive (formerly Keasler Street) according to plat of Pine Brook Development, made by W. N. Willis, Engineer, March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at Page 148, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Elaine Drive, joint front corner of Lots 9 and 11, and running thence along the common line of said lots, N. 53-37 E. 150 feet to an iron pin, joint rear corner of said lots with lots 64 and 65; thence S. 33-31 E. 85.8 feet to an iron pin in line of lot 5; thence along rear line of lots 5 and 4, S. 51-22 W. 150 feet to an iron pin on Elaine Drive; thence along Elaine Drive (formerly Keasler Street) N. 33-31 W. 91.7 feet to an iron pin, the point of beginning.

This conveyance is made subject to the Restrictive and Protective Covenants applicable to Pine Brook and recorded in the R.M.C. Office for Greenville County, South Carolina, in Book of Deeds 443, at Page 307, and in Book of Deeds 462, at Page 33.

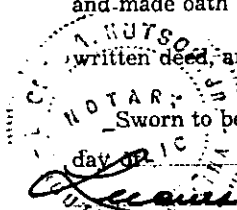

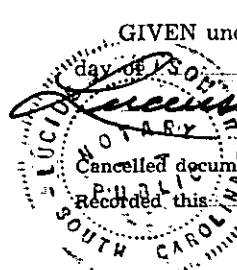
