to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his heirs and assigns, forever,

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designates as lot 22 of Section "B" of Englewood Estates as shown by a plat thereof dated November 1951, recorded in R. M. C. Office for Greenville County in Plat Book "BB", at page 11.

BEGINNING at an iron pin on the west side of Cherokee Drive and running N. 2-30 E. 75 feet to an iron pin on Cherokee Drive, joint front corners of lots 22 and 21; thence along the line of lots 22 and 21 N. 87-30 W. 116.2 feet to an iron pin, joint rear corners of lots 21, 10, 11, and 22; thence with the rear line of lots 11 and 22 S. 2-30 W. 75.6 feet to an iron pin, joint rear corners of lots 11, 12, 23 and 22; thence along the line of lots 23 and 22 S. 87-30 E. 124.65 feet to an iron pin on the west side of Cherokee Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any negro or person of African descent. No residence is to cost less than \$5000.00; no residence shall be erected on said lot nearer than 50 feet to the front line; no residence shall be built on said lot unless it have 50 feet or more frontage; and no outside toilets are permitted --sewage must be disposed of by approved septic tanks.

GRANTEE is to pay taxes for the year 1956.

THIS DEED is conveyed subject to any rights of way now in existence.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
