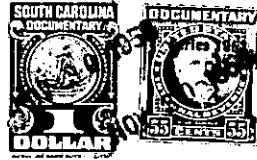

All that piece, parcel or lot of land in Chick Springs Township, County of Greenville, State of South Carolina, located near Pleasant Grove Baptist Church, lying on the Southeast side of the Old Greenville-Spartanburg Road and being known as lot FORTY NINE (49) on a plat on property of J.
