BEGINNING at a stake on the right of way of LANE DRIVE and running thence, S. 79-50 W; 159.9 feet to a stake at the corner of lot # 9; thence along line of lot # 9, S. 30-0 E. 45 feet to a stake at the corner of lot # 7, thence N. 60 E. 150 feet along line of lot # 7, to the right of way of LANE DRIVE; thence N. 30-0 W. 100 feet along right of way of LANE DRIVE to the beginning corner.
