in consideration of the sum of Three Hundred Eighty and No/100 in the State aforesaid, DOLLARS,

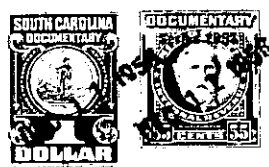
